# **Course Description**

In this course we will be looking at the category of "priestly" as it is used by scholars to describe a variety of ancient Israelite and early Jewish literary works. This course will examine a variety of writings from the 7th–2nd centuries BCE related to issues of ritual, cult, temple, priests, and sacrifice. Together we will investigate the possibility of literary relationships between some texts, question assumptions related to "rewritten bible" models, and reevaluate the common assumption that the pentateuchal priestly writings are the "base text" for nearly all later priestly literatures. We will consider each text as a literary work in its own right and as the product of a specific socio-historical context, an approach that will point to diverse and divergent cultic ideologies across Judea and the Diaspora (particularly in Egypt). Some of the texts we may study are: the pentateuchal priestly narrative (P), Ezekiel, Chronicles, documents from Elephantine, the Temple Scroll, the Letter of Aristeas, and the Aramaic Levi Document. Other texts may be brought into our discussions as well.

Knowledge of Biblical Hebrew, Aramaic, and/or Greek is helpful, but not required for the course. All texts will be made available in English translation.

# Course Requirements and Grading

Participation (60%)

Participation will be broken down into two categories for this course:

1. general participation in the week-to-week course discussions (40%)

- 2. completion of at least two book presentations/summaries (10% each; 20 % total).
  - a. MA students have the option to complete only one book presentation

# Final Course Paper (30%)

Students are expected to pursue a research project related to some aspect of "priestly writings" that results in a 20-minute presentation (approximately 3000–3500 words depending on how quickly you speak), to be given at the final meeting of the course. This presentation should include either a handout or slides to help the audience follow your talk.

- → **Due October 27:** An abstract (250–300 words) along with the title of your presentation should be submitted via email by 5pm.
- → Week of Oct 31 –Nov 4: I will return your abstracts to you with feedback and suggestions
- → **(Optional) Due Dec 1:** First drafts of your papers should be submitted to via email by 5pm. Comments will be returned to you by Dec 8.
- → Week of Dec 12: Final presentation of your paper at the class conference. A final copy of your paper should be submitted to me via email before the start of the conference.

# Participation in the Class Conference (10%)

All students are expected to attend and participate in the end of the semester course conference. Active participation includes each student asking at least one question of each presenter.
